Monthly OPS Notes Release: Upcoming Compliance Dates 2017

A few final rules have been issued recently that have delayed the effective dates of some of the regulations our credit unions have been trying to plan for. Below is a summary of two changes, along with some reminders of other effective dates that are taking place this year!

DOL Fiduciary Rule

The Department of Labor (DOL)'s final rule that defines who is considered a fiduciary investment adviser, describes the kinds of communications that would constitute investment advice, and adopts new exemptions to permit investment advice fiduciaries to continue to receive compensation under certain circumstances was originally effective on April 10, 2017. However, a 60-day delay has resulted in an effective date of June 9, 2017.

Prepaid Accounts Rule

The CFPB has announced a final rule delaying by six months the general effective date of the new rules governing prepaid accounts. The new rules for prepaid accounts under the Electronic Fund Transfer Act/Regulation E and the Truth In Lending Act/Regulation Z will now take effect on April 1, 2018.

While those delays will give credit unions extra time to work on changes to their policies, procedures and processes, there are still a few other rules that are scheduled to become effective this year. Credit unions should make sure they are aware of these upcoming changes:

- Same Day ACH (Phase 2) Effective September 15, 2017
- Military Lending Act Credit Cards Effective October 3, 2017
- Mortgage Servicing Rule Amendments Effective October 19, 2017 and April 19, 2018
- Home Mortgage Disclosure Act (HMDA) Effective January 1, 2018

Content FAQs
